Virginia Baptist Children's Home and Family Services

Glenda Pollard presented the 2010 Annual Human Rights Report for Virginia Baptist Children's Home and Family Services to the Committee.

VIII. Provider Updates

Ms. Pollard notified the Committee that the Virginia Baptist Children's Home and Family Services is in preliminary stages of pursuing a license to provide Day Support Services.

IX. Receipt of Notice

Family Preservation Services, Inc.

Rod McMurray requested the Committee's approval to extend Family Preservations Services' affiliation to include the provision of Day Treatment Services for children at Powell Valley Middle School, Wise County; L.F. Addington Middle School, Wise County; Marion High School, Smyth County; Council Elementary School, Dickenson County; Haysi High School, Dickenson County; and Richlands Middle School, Tazewell County. Motion was made by Ms. Stacy and seconded by Ms. Mullins to extend Family Preservation Services' affiliation to include the above. Motion carried.

Highlands Community Services

Lorie Horton provided written notification in reference to the Venable and Hoss Sponsor Homes, which were discussed at the June 15, 2011 meeting. In addition, she requested the Committee's approval to extend Highlands Community Services' affiliation to include the provision of Day Treatment Services at the William N. Neff Center in Abingdon, Virginia. Lastly, Ms. Horton notified the Committee that Highlands Community Services would be requesting an extension of their affiliation to provide Day Treatment Services to Abingdon Elementary School at the next Committee meeting. Motion was made by Ms. Mullins and seconded by Ms. Stacy to extend the affiliation to include all the above locations with written notification of the Abingdon Elementary School location to be included in the meeting packet for the Committee meeting in October. Motion carried.

X. Other Business

Motion was made by Ms. Mullins and seconded by Ms. Hawkins that the Southwest Local Human Rights Committee go into closed session pursuant to VA Code 2.2-3711.a (4) and (15) for the purpose of protecting the privacy of individuals in personal matters not related to public business and the discussion of medical and mental health records, namely to review Annual Reports and Licensing updates including a specific case review.

Ms. Mullins moved that the Southwest Regional Human Rights Committee reconvene into public session. Motion carried.
